1. That the legal fiction known as CINDY LYNNE SWANSON was lawfully liened and bound by a Private Security Agreement executed by the living woman Cindy-Lynne: Swanson.
2. That CLS TRUST is the Secured Party Lienor (SPL), holding legal title and perfected lien rights over the DEBTOR via UCC-1 financing statement, File No. U250111302519.
3. That CM TRUST, also known as COURTNEY MICHAEL TRUST, is the Secured Party Holder (SPH), holding equitable interest pursuant to assignment recorded by UCC-3 filing.
4. That all prior UCC-3 filings inconsistent with this structure have been voided by formal UCC-3 amendment (B3668-7229) declaring such filings unauthorized.
5. That notice of collateral, including general intangibles, registered vehicles, and all derived assets, has been publicly perfected and recorded under applicable commercial law.
6. That this structure separates legal and equitable title between private trust entities in accordance with lawful contract, fiduciary assignment, and agency.
